**School District Educational Alternatives for Expelled Students**

Students expelled for any of the offenses listed in subdivision (a) or (c) of Section 48915 of the California Education Code shall not be permitted to enroll in any district-operated program during the period of expulsion - unless it is a community day school (EC 489152)

**CLASSROOM REQUIREMENTS - Michigan**

Classroom models below include required components When planning the program year, scheduled breaks, holidays, and possible inclement weather days should be taken into account to ensure that the minimum number of program weeks is met Classrooms in place for more than one academic year must have a minimum of 30 weeks of classroom sessions

### **Prekindergarteners Left Behind: Expulsion Rates in State ...**

4½ times more likely to be expelled than were girls Expulsion rates were lowest in classrooms in public schools and Head Start and highest in faith-affiliated centers and for-profit child care The likelihood of expulsion decreases significantly with access to classroom-based mental health consultation
