Taxability of a Revocable Living Trust/Inheritance Tax

subjects the property to Pennsylvania Inheritance Tax Accordingly, the Estate shall file a Non-Resident Pennsylvania Inheritance Tax Return and report the fair market value of the real estate as of Decedent's date of death, to be taxed at the lineal rate of tax, four and one-half percent
